#### Section 10.6 Responsibilities of Officers

(from club by-laws)

#### 10.6.3 Vice Presidents

The vice president of the Corporation (the "Vice President") shall, in the absence or disability of the President, perform all the duties of the President and, when so acting, have all the powers of and be subject to all the restrictions upon, the President. The Vice President shall have such other powers and perform such other duties as may be prescribed by the Board. The Corporation shall appoint up to two (2) Vice Presidents.

#### 10.6.4 Secretary

In conjunction with the General Manager, the secretary of the Corporation (the "Secretary") shall be the custodian and have charge of all books, papers, instruments and record of the Corporation.

Additionally, the Secretary shall keep a full and complete record of the proceedings of the meeting of members and of the Board of Directors.

#### 10.6.7 Additional Officers (7th Board Director)

The Board may empower the President to appoint or remove such other Officers as the business of the Corporation may require, each of whom shall hold office for such period, have such authority, and perform such duties as are provided in these Bylaws or as the Board from time to time may determine.
